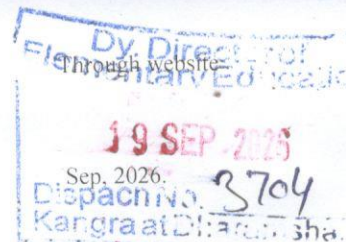

1. The Director of School Education (Ele.), Himachal Pradesh, Shimla-171001
2. All the concerned Principals/ Headmasters GSSS/ GHS are therefore directed to implement the above transfer(s) adjustments(s) orders keeping in view the conditions given if the implementation of above is not administratively feasible and if more than one approval(s) has/have been conveyed for the same station for implementation or the same is/are not administratively feasible or contractual policy has not been relaxed in case of contract employees and in such orders where the stay of incumbent(s) is acute short stay and transfer orders are on mutual basis or against vacancy basis, then orders be referred back immediately giving full details. It may also be noted that in all the above mentioned transfers consent/mutual consent be obtained first in order to avoid litigation.
3. While regulating/implementing transfers of teachers, the norms and standards for providing teachers in a school as contained under Sr. No. 1 (b) in the schedule of RTE Act 2009 be compiled with strictly. In case of any violation of these instructions, you will be entirely responsible being an implementing and appointing authority. However before implementing these transfer order it may be ensured that the school does not remain without teacher.
4. In case of transfer on mutual basis, in condonation of short stay, willingness of the concerned teachers be obtained by the Principal/Headmaster/Incharge/HOD before relieving him/her. In case he/she is not willing for this transfer, then he/she may not be relieved and the case may be referred back alongwith his/her written unwillingness.
5. **In case of contract teachers transfer order may not be implemented if the contractual policy has not been relaxed.**
6. **"If any transferred teacher is assigned census duty, the implementation of the transfer order shall be deferred and will take effect only after the completion of the election process"**
7. In case of the transfer on vice/versa basis the following points may be examined in r/o the transferee.
 - Whether he/she has more than two years of service left.
 - Whether as per his/her service record, he/she does not suffer from any physical handicapped/serious medical problem.
 - Whether he/ she served in a tribal/hard area before (in case the transfer is being proposed to a tribal/hard area.)
 - These transfer orders should meet all the conditions mentioned above. Otherwise the transfer orders may be referred back to this office.

These transfer orders should meet all the condition mentioned above, and in the office memorandum of department of personal dated 10.07.2013 titled Comprehensive Guiding Principles 2013, for regulating the transfer of State Government employees; otherwise these transfer orders may be referred back to this office.
